

Movements of citizens in Albania

February 2020

Tiranë 25 March 2020: Arrivals of Albanian and foreign citizens to the territory of Albania, in February 2020 are 616,496.

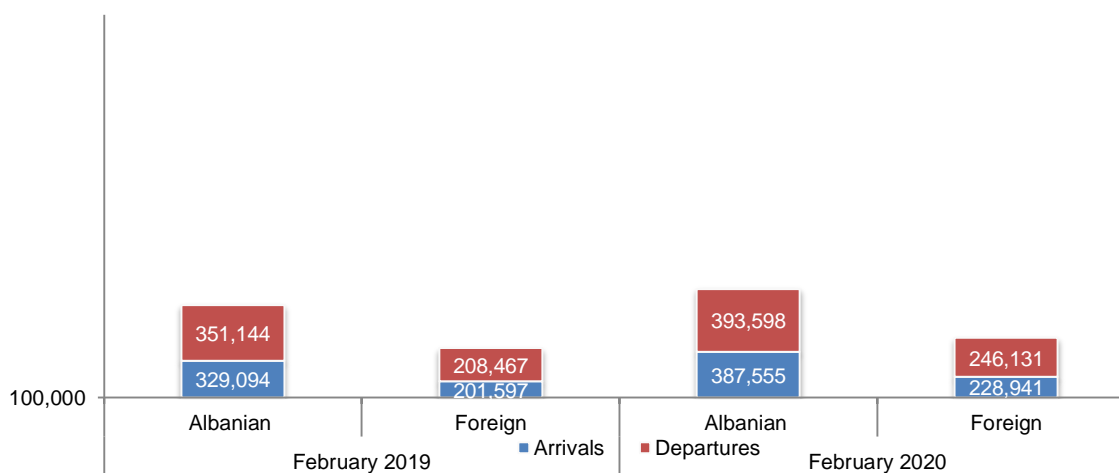
Compared to February 2019, this indicator increased 16.2 %. In February 2020, arrivals of foreign citizens in the country are 228,941. Compared to February 2019, this number increased by 13.6 %.

The number of foreign citizen arrivals to the territory of Albania during the first two months of 2020, is 478,402, increasing by 16.4 %, compared with the same period of 2019.

In February 2020, among the countries with the highest incomes of citizens in Albania, Poland had the highest growth, while the lowest increase is marked by the citizens of SHBA, compared with February 2019.

In the two months of 2020, the country with the highest inflows of citizens in Albania is Poland by 40.4 %, while SHBA had the lowest income of citizens with a decrease of 7.2 %.

Albanian and foreign citizens' departures from the country during February 2020 are 639,729 marking an increase by 14.3 % compared to the same period of the previous year. Departures of Albanian citizens from the territory of Albania during February 2020 are 393,598. Compared to February 2019, this number has increased by 12.1 %. Departures of foreign citizens from the territory of Albania during February 2020 are 246,131. Compared to February 2019, this number increased by 18.1 %.

The number of Albanian citizens leaving the territory of our country in the two months of 2020 is 924,663 increasing by 14.9 % compared to the previous year.

Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens, by means of transport (sea, air, land and border points), is the measurement of some statistical indicators related to tourism.

Definitions

Arrivals : Include all entries at the border points (by, air, sea and land).

Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the year is counted every time as a new entry.

Departures: Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during a year is always counted as a new exit.

Visitor: For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for:

Visits for *personal purposes* grouped as follows:

1. Holidays, visit to relatives, etc.;
2. Health treatment;
3. Religious;
4. Transit.

Visits for *Business category* includes all business and professional activities outside the usual environment.

Data Source: Administrative data are provided by the Ministry of Internal Affairs (State Police, Border and Migration Directorate).

The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control", Article 17 "Facilitation of Border Verifications", where during the tourist season or increased inflow, at the moment of entry of citizens at the border, does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity, when they cross several times a day, are not registered at the entrance;
- A good share of Albanians hold dual citizenship, who at the time of border crossing may declare different citizenship at exit from it at the entrance, etc.
