



Movements of citizens in Albania

February 2024


Tirana, 25 March 2024: Arrivals of Albanian and foreign citizens to the territory of Albania, in February 2024 are 981,295. Compared to February 2023, this indicator increased by 41.1 %. Albanian and foreign citizen's departures from the territory of Albania during February 2024 are 1,002,781 marking an increase by 44.7 %, compared to the same period of the previous year.

Citizen's arrivals

In February 2024, arrivals of Albanian citizens to the territory of Albania are 500,756. Compared to February 2023, this number increased by 29.8 %.

Arrivals of foreign citizens to the territory of Albania are 480,539. Compared to the same period of 2023, this number increased by 55.4 % (fig.1).

Citizen's departures

Departures of Albanian citizens from the territory of Albania during February 2024 are 507,095. Compared to February 2023, this number has increased by 30.1 %.

Departures of foreign citizens from the territory of Albania during February 2024 are 495,686. Compared to the same period of previous year, this number increased by 63.4 % (tab.1).

In February 2024, the region with the highest inflows of citizens in Albania is the European region with 459,700 citizens, followed by America and East Asia and Pacific, respectively with 8,147 and 2,979 citizens (tab.2).

In February 2024 compared to February 2023, the arrivals of foreign citizens marked an increase:

- for personal purposes by 55.4 %;
- for vacation purposes, visiting relatives, etc. by 56.9 %;
- for business and professional purposes by 53.9 % (tab. 3).

Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens, by means of transport (sea, air, land and border points), is the measurement of some statistical indicators related to tourism.

Definitions

Arrivals : Include all entries at the border points (by, air, sea and land).

Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the year is counted every time as a new entry.

Departures: Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during a year is always counted as a new exit.

Visitor: For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for:

Visits for personal purposes grouped as follows:

- 1. Holidays, visit to relatives, etc.;
- 2. Health treatment,
- 3. Religious;
- 4. Tranzit.

Visits for *Business category* includes all business and professional activities outside the usual environment.

Data Source: Administrative data are provided by the Ministry of Internal Affairs (State Police, Border and Migration Directorate).

The data are preliminary and subject of revisions. For more information refer to: http://www.instat.gov.al/en/documentation/quality-in-statistics/ statistical revision policy. The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control", Article 17 "Facilitation of Border Verifications", where during the tourist season or increased inflow, at the moment of entry of citizens at the border, does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity, when they cross several times a day, are not registered at the entrance;
- A good share of Albanians hold dual citizenship, who at the time of border crossing July declare different citizenship at exit from it at the entrance, etc.
