

# Consumer Price Index

### **April 2024**

Tirana, on May 08, 2024: Consumer Price Index in April 2024 arrived 117.1 against December 2020 as reference period.


The annual rate of consumer price index in April 2024 is 2.1 %, a year before was 4.6 %. Compared with March 2024 the monthly change of consumer price index is -0.2 %.



Contribution of main groups in yearly changes of CPI: Annual growth rate in April was influenced mostly from prices of group "Food and non-alcoholic beverage" by +0.51 p.p., followed by "Housing, water, electricity and other fuel" group contributed by +0.44 p.p.. Also, prices of "Furniture household goods and maintenance" group influenced by +0.26 p.p., prices of "Alcoholic beverages and tobacco" group influenced by +0.16 p.p., prices of "Hotels, coffee-house and restaurants" and "Miscellaneous goods and services" groups contributed by +0.15 p.p. each of them, prices of "Clothing and footwear" group contributed by +0.12 p.p., "Recreation and culture" group contributed by +0.10 p.p., prices of "Health" group contributed by +0.07 p.p., prices of "Transport" and "Education service" "groups contributed by +0.06 p.p. each of them.

**Yearly rates of main groups:** Compared to April 2023, prices increased the most in the "Recreation and culture" group by 4.4 %, followed by "Furniture household goods and maintenance" by 3.5 %, "Clothing and footwear" by 3.4 %, "Alcoholic beverages and tobacco" by 3.3 %, "Miscellaneous goods and services" by 2.7 %, "Housing, water, electricity and other fuel" by 2.3 %, "Education service" by 2.2 %, "Health" by 1.7 %, "Food and non-alcoholic beverage" by 1.5 %, and "Transport" by 1.0 %.

Within the food group prices of "vegetables included potatoes" subgroup signed an increased by 5.4 %, followed by "fish" by 5.2 %, "sugar, jam honey, syrup, chocolates and sweets" by 4.1 %, "milk, cheese and eggs" by 3.6 %, "meat" by 2.4 %, etc.

**Monthly rates of main groups:** Compared with March 2024 prices of "Food and non-alcoholic beverage" group decreased by 0.7 %, On the other hand, prices of "Recreation and culture" increased by 1.1 %, followed by "Alcoholic beverages and tobacco" by 0.5 %, "Furniture household goods and maintenance", "Transport" and "Hotels, coffee-house and restaurants" by 0.2 % each of them, "Health" and "Miscellaneous goods and services" by 0.1 % each of them.

## **METHODOLOGY**

### - Methodological changes

In January of each year some methodological changes and new developments were carried out in CPI:

- Update of weights: Weights are changed; they are now based on the average expenditure from 2022 Household Budget Survey.
- Update of basket: The list of goods and service content 331 products.
- Update of list of the outlets where the prices are collected is updated.

Started from January 2021, the consumer price index is calculated with the new base period. December 2020 is considered as the base period (December 2020 = 100).

#### - Definitions

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although upto-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices and the latest 12 month to the average of the previous 12 months.
