



# **Import Price Index**

## Second quarter, 2024

**Tirana, 04 September 2024:** The Import Price Index, in the second quarter of 2024, reached 108.3 against 2021. Compared to the second quarter of 2023, the import price index marked a decrease by 1.0 %, a year before this change was +0.2 %. Compared to the first quarter of 2024 the index marked an increase by 0.2 %.

**Annual change:** Import prices of products in the section "Mining and quarrying" marked a decrease of 1.5 %, followed by "Manufacturing" section with the highest weight of 93.5 % marked a decrease by 1.2 %, "Water supply, treatment activities and waste management" by 0.2 %. On the other hand, "Electricity, gas, steam and air conditioning" marked an increase with 1.0 %. Within the "Manufacturing" section with the highest decrease is marked in the section "Paper printing and regrouping of recorded media" by 6.2 %, followed by "Manufacture of dressing: wearing apparel" by 4.6 %, "Manufacture of woods and products of wood and oak, except furniture; manufacture of articles of straw and reed" by 3.8 %, "Manufacture of textiles" by 2.7 %, "Manufacture of food products", "Manufacture of rubbers and plastic products" and "Metallurgy" by 2.3 % each of them, "Manufacture of machinery and equipment" by 1.5 %. On the other hand, prices in the activity "Manufacture of fabricated metal products, except machinery and equipment" marked an increase by 3.4 %, followed by the section "Other transport equipment" by 1.5 %, "Manufacture of leathers and leather products" by 1.0 %, "Other Industries" by 0.9 %, etc.

**Quarterly change**: Compared to the first quarter of 2024, import prices of products in the section "Mining and quarrying" has marked an increase by 0.6 %, followed by sections "Water supply, treatment activities and waste management" by 0.5 %, "Manufacturing" by 0.3 %. On the other hand, "Electricity, gas, steam and air conditioning" marked a decrease by 0.7 %. Within the section "Manufacturing" the largest price increase is marked in the activity "Manufacture of furniture" by 1.2 %, followed by "Manufacture of tobacco products" by 1.0 %, "Manufacture of fabricated metal products, except machinery and equipment" by 0.9 %, "Manufacture of textiles" and "Manufacture of pharmaceutical products and pharmaceutical preparations" by 0.8 % each of them. On the other hand, prices in the activity "Manufacture of dressing: wearing apparel" marked a decrease by 1.3 %, followed by "Metallurgy" by 0.7 % and "Manufacture of optics, electronics and computer products" by 0.3 %.

# Methodology

The industrial import price index measures the changes of transaction prices of imported products to be traded in the domestic market.

### INSTAT calculates and publish:

- · Import Price Index
- · Quaterly and anually chanches of the index.

### Import Price Index covers the following economic activities:

Section B Mining and quarrying

Section C Manufacturing

Section D Electricity gas and steam supply

Section E Water supply sewerage and waste

#### Index calculation

The indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA 2008) in 6 – digit level and are published in two digit level.

### **Measures of index**

**The annual change** measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one –off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
