



Movements of citizens in Albania

September 2024

Tirana, 25 October 2024: During the month of September 2024, it results that 1,794,274 Albanian and foreign citizens entered in the Republic of Albania territory. This indicator has increased by 8.7 %, compared to September 2023.


1,927,816 Albanian and foreign citizens have left the Republic of Albania territory, marking an increase by 12.6 %, compared to the same period of the previous year.

Citizen's arrivals

In September 2024, the number of Albanian citizens who entered the Albanian territory is 648,184, increasing by 18.6 %, compared to September 2023.

Arrivals of foreign citizens to the territory of Albania are 1,146,090. Compared to the same period of 2023, this number increased by 3.8 % (fig.1).

Citizen's departures

In September 2024, 698,268 Albanian citizens are counted to have left the territory of Albania, marking an increase of 14.2 %, compared to September 2023.

Departures of foreign citizens from the territory of Albania during September 2024 are 1,229,548. Compared to the same period of the previous year, this number decreased by 11.7 % (tab.1).

In September 2024, 95 % of foreign citizens arrivals in Albania are from the region of Europe.

Southern Europe accounts 69 % of the foreign citizens arrivals from the European continent, followed by Western Europe with 12 % (tab.2).

The purpose of arrivals of foreign citizens in the Albanian territory, in 98 % of cases, is for personal purposes, dominated by arrivals for Holidays, visit to relatives, etc. In September 2024, this indicator has marked an increase by 0.9 %, compared to September 2023. The arrival of foreign citizens for business and professional purposes also increased significantly in September, by 60.9 % (tab.3).

Movements of Albanian and foreign citizens

Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens. by means of transport (sea. air. land and border points). is the measurement of some statistical indicators related to tourism.

Definitions

Arrivals: Include all entries at the border points (by. air. sea and land).

Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the year is counted every time as a new entry.

Departures: Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during a year is always counted as a new exit.

Visitor: For statistical purposes on tourism. the term "visitor" represents a "person who travels in a different place from that in which he resides. in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for:

Visits for personal purposes grouped as follows:

- 1. Holidays. visit to relatives. etc.;
- 2. Health treatment.
- 3. Religious;
- 4. Tranzit.

Visits for *Business category* includes all business and professional activities outside the usual environment.

Data Source: Administrative data are provided by the Ministry of Internal Affairs (State Police. Border and Migration Directorate).

The data are preliminary and subject of revisions. For more information refer to: https://www.instat.gov.al/media/2940/revision_policy_2016.pdf The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control". Article 17 "Facilitation of Border Verifications". where during the tourist season or increased inflow. at the moment of entry of citizens at the border. does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity. when they cross several times a day. are not registered at the entrance;
- A good share of Albanians hold dual citizenship. who at the time of border crossing September declare different citizenship at exit from it at the entrance. etc.
