




Foreign Trade in Goods

October 2024

Tirana, November 18, 2024: On October 2024 the value of exports was ALL 31 billion, decreasing by -15.2 % compared with the same period of previous year and increasing by 0.9 % compared with September 2024. The value of imports was ALL 77 billion, decreasing by -1.5 % compared with the same period of previous year and increasing by 8.3 % compared with September 2024. This month the trade deficit is ALL 46 billion, increasing by 10.6 % compared with October 2023 and increasing by 13.9 % compared with September 2024.

Fig.1 Annual change in Foring Trade (%)




In the first ten months of 2024, the value of exports was ALL 317 billion, decreasing by -14.3 %, compared with previous year and the value of imports was ALL 743 billion, increasing by 2.0 % compared with previous year. Trade deficit was ALL 426 billion, increasing by 18.8 % compared with the same period of 2023.

The influence of the main groups in the annual change in exports:

In annual decrease of exports by -15.2 % this month, a contribution was given by the groups: "Constructions materials and metals" with -8.2 percentage point, "Textile and footwear" with -3.5 percentage point, "Minerals, fuels, electricity" with -2.9 percentage point, etc.




Exports during the ten months of 2024 are decreased by -14.3 % compared with the same period of previous year. The main groups that influenced more in annual decrease of exports are: "Minerals, fuels, electricity" with -5.6 percentage point, "Textile and footwear" with -5.0 percentage point, "Constructions materials and metals" with -2.2 percentage point.

The influence of the main groups in the annual change in imports:

In October 2024 the decrease of imports by -1.5 % compared with the same month of the previous year, was negatively affected by the groups: "Constructions materials and metals" with -3.3 percentage point, "Minerals, fuels, electricity" with -1.0 percentage point, "Textile and footwear" with -0.8 percentage point, etc. While a positive contribution was given by the group: "Machinery, equipment and spare parts" with +2.8 percentage point, "Food, beverages and tobacco" with +0.7 percentage point.





In the first ten months of 2024, imports are increased by 2.0 % compared with the same period of previous year. The groups affected positively in annual increase of imports, are: "Machinery, equipment and spare parts" with +2.7 percentage point, "Food, beverages, tobacco" with +1.2 percentage point. While a negative contribution was given by the groups: "Minerals, fuels, electricity" with -1.2 percentage point, "Textile and footwear" with -0.9 percentage point, "Leather and leather manuf" with -0.3 percentage point.

The performance of trade in goods by partner countries


In October 2024, countries with which Albania has had the highest decrease of exports, compared to October 2023 are: Kosovo (24.0 %), Italy (13.6 %), Spain (4.7 %). While, countries with which has had an increase of exports are: Greece (12.3 %), Germany (11.4 %).

In the first ten months of 2024, countries with which Albania has had the highest decrease of exports, compared to the same period of 2023 are: Greece (20.2 %), Italy (14.2 %), Kosovo (8.5 %), etc. While, countries with which has had an increase of exports are: USA (68.3 %), China (16.8 %), etc.

In October 2024, countries with which Albania has had the highest decrease of imports, compared to September 2023 are: North Macedonia (17.6 %), Italy (3.4 %), etc. While, countries with which has had an increase of imports are: Greece (28.1 %), Turkey (6.6 %), China (2.7 %), etc.

In the first ten months or 2024, countries with which Albania has had the highest increase of imports, compared to the same period of 2023 are: Greece (19.9 %), Turkey (16.3 %), China (0.2 %), etc. While, countries with which has had a decrease of imports are: North Macedonia (14.5%), Italy (3.2), Spain (2.0 %), etc.

Trade with the EU countries is 60.3 % of total trade. In October 2024, exports to EU countries occupied 75.7 % of total exports and imports from EU countries occupied 54.1 % of total imports.

The main trade partners remain: Italy (29.4 %), China (8.6 %), Turkey (8.3 %) and Greece (7.4 %).

Trade with the EU countries, in the first ten months of 2024 is 57.6 % of total trade. In this period, the share of exports to EU countries was 71.4 % of total exports and share of imports from EU contries was 51.6 % of total imports.

The main trade partners are: Italy (28.0 %), China (8.3 %), Turkey (8.1 %) and Greece (7.2 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
