# Snapshot – 1st traineeship round

The first round of traineeships under the IPA 2022 contract concluded at the end of April 2025, offering a valuable opportunity for trainees from partner countries to engage directly with Eurostat, and the statistical offices of some EU Member States' and Switzerland. Trainees were hosted in a variety of statistical areas, with each experience providing hands-on exposure to both methodological and operational aspects of European statistical practices. Trainees reported that the experience significantly supported their professional development by deepening their technical understanding, improving practical skills, and strengthening their ability to contribute to ongoing work at home.

In addition to technical knowledge, trainees gained important insights into institutional workflows, data validation procedures, and the coordination needed

to align national practices with European standards. Through mentorship and hands-on assignments, they developed a clearer understanding of how statistical outputs are produced, reviewed, and communicated. Exposure to different working environments and legal frameworks further broadened their perspective and enhanced their ability to apply this learning in their home institutions.

Overall, the first round of traineeships successfully fostered knowledge exchange, built technical capacity, and encouraged professional growth. The positive feedback from participants underlines the importance of continuing this component of the IPA 2022 contract. More experiences and reflections from trainees will be featured in the upcoming 6-monthly newsletter.
