**DECISION no. 426, dated 15.5.2013**

**FOR  
ESTABLISHMENT, FUNCTIONING AND TASKS OF THE NATIONAL  
COMMISSION FOR NOMENCLATURE**

Pursuant to Article 100 of the Constitution and Article 12/2 of Law no. 9180, dated 5.2.2004, "On official statistics", as amended, on the proposal of the Prime Minister, the Council of Ministers

**D E C I D E D :**

1. Establishment of the National Commission for Nomenclature, which updates, adapts, and implements official economic and social classifications in accordance with European and international nomenclatures.
2. The National Commission for Nomenclature chaired by the General Director of INSTAT consists of:
  - a) One representative from the Bank of Albania;
  - b) One representative from the Ministry of Innovation and Information and Communication Technology;
  - c) One representative from the Ministry of Finance
  - ç) One representative from the Ministry of Economy, Trade and Energy;
  - d) One representative from the Ministry of Agriculture, Food and Consumer Protection;
  - dh) One representative from the Ministry of Interior;
  - e) One representative from the Ministry of Public Works and Transport;
  - ë) One representative from the Ministry of Education and Science;
  - f) One representative from the Ministry of Health;
  - g) One representative from the Ministry of Labor, Social Affairs and Equal Opportunities;
  - gj) One representative from the Ministry of Environment, Forests and Water Administration;
  - h) One representative from the Union of Chambers of Commerce and Industry;
  - i) One representative from the General Directorate of Customs;
  - j) One representative from the General Directorate of Taxation;

- k) One representative from the National Registration Center;
  - l) One representative from the Social Insurance Institute;
  - ll) Three representatives from INSTAT.

- 3. Representatives of the institutions, members of the commission, are appointed by the heads of these institutions, according to the criteria and requirements presented by the Institute of Statistics.
  - 4. For the preparation of the meetings of the National Commission for Nomenclature, the secretariat of the commission is established, composed of specialists of the Institute of Statistics. The rules for the functioning of the Secretariat of the Commission are determined by the regulation approved by the National Commission for Nomenclature.
  - 5. The National Commission for Nomenclature convenes at the invitation of the Chairman. Meetings of the Commission are held according to the rules set out in law no. 8480, dated 25.8.1999 "On the functioning of collegial bodies of state administration and public entities".
  - 6. The National Commission for Nomenclature may set up working groups, according to its areas and needs, composed of all the institutions included in the Commission or a part of them. The rules for the functioning of these groups and the degree of their responsibility are determined by a special decision of this commission.
  - 7. The Nomenclatures approved in advance by the National Commission for Nomenclature are approved by a special decision of the Council of Ministers.
  - 8. DCM No. 327 dated 18.7.1994 "On the approval of the implementation of the Nomenclature of Economic Activities", as amended and any other provision that is contrary to this decision, is repealed.
  - 9. Institute of Statistics and the institutions mentioned in point 2 of this decision are in charge of the implementation of this decision.

This decision enters into force after publication in the Official Gazette.<sup>1</sup>
