Snapshot – Exchange of best practices: Study Visits to Czechia and Spain

In May and June 2025, three study visits offered participants from the Western Balkans and Türkiye a unique opportunity to deepen their understanding of advanced practices in national and regional accounts. Hosted by the Czech Statistical Office (CZSO) and the Spanish Statistical Office (INE), the visits highlighted practical applications of the ESA 2010 framework and fostered mutual learning among participating countries.



SP 1.4 National Accounts-Study Visit, 14-16 May 2025, Prague, Czech Republic

At the CZSO, two study visits focused on national accounts compilation and seasonal adjustment. Participants explored the Czech approach to building consistent and transparent national accounts using a bottom-up methodology, including GDP balancing within supply and use tables, capitalisation of R&D and small tools, and estimation of dwelling and insurance services. Special emphasis was placed on quarterly sector accounts and integration with government and financial statistics. A second visit provided hands-on training in seasonal and calendar adjustment using JDemetra+, covering model estimation, outlier treatment, benchmarking techniques, and transmission of seasonally adjusted data to Eurostat. These sessions reinforced the importance of methodological rigour and transparent revision policies, offering replicable models for strengthening data quality and harmonisation across the IPA region.

Meanwhile, a study visit hosted by INE in Spain focused on regional accounts, welcoming experts from TurkStat. The exchange examined Spain's comprehensive approach to compiling GDP by region and economic activity, including recent innovations in using micro-level administrative data. The Turkish delegation shared their own experience with major system revisions and the gradual expansion of regional GDP coverage. The visit served as a

valuable platform for dialogue on improving the production of regional accounts and preparing for future benchmark revisions in line with ESA requirements.

Together, these study visits showcased the power of peer exchange in advancing statistical expertise, strengthening institutional practices, and promoting alignment with European standards.
