

## **Road Transport Statistics**

### Fourth quarter, 2024

Tirana, 25 January 2024: The length of the road network in use during the fourth quarter of 2024, is 3,606\* km referring to different categories, such as motorway, interurban or urban and local roads. Secondary interurban roads occupy about 74.2 % of the length of the road network.

The total number of road vehicles, for the fourth quarter of 2024, with the status of "active" and "temporarily deregistered", in the territory of the Republic of Albania until December is 959,226 vehicles.

In the category of road vehicles by type, the largest percentage of the total number of road vehicles is occupied by "Passenger cars" (80.8 %), "Mixed transport vehicles" (6.0 %) and "Motor vehicles" (5.8 %).

The highest number of road vehicles in the fourth quarter of 2024, are in prefecture of Tirana, accounting 34.8 % of the total road vehicles in country, followed by the district of Durrës by 13.6 % of the total road vehicles.

The prefectures with the lowest number of road vehicles are Gjirokastër by 2.2 % and prefectures Kukës by 2.4 % to the total road vehicles.

During the fourth quarter of 2024, 22,904 road vehicles were registered for the first time. In the category of road vehicles according to the type registered for the first time, the largest percentage is occupied by "Passenger Cars" with 83.5 % and "Motorcycles" with 5.9 %.

The highest number of road vehicles registered for the first time is in the district of Tirana, accounting for 38.0 % of the total road vehicles registered in the country in the fourth quarter of 2024. The counties with the smallest number of road vehicles registered for the first time are Gjirokastër county with 1.4 % and Dibër with 2.4 % of the total road vehicles.

# Methodology

The Transport Statistics publication presents the results on the transport of goods and passengers by type, as well as the export and import of goods by mode of transport, on a monthly basis. The data are administrative. The main source of information is the Ministry of Infrastructure and Energy and General Directorate of Customs.

#### **Definitions**

**Transport**: Movement of people and / or freights using various means of transport. Transport is carried out by rail, land, sea and air.

Road transport: Any movement of goods using a road vehicle on a defined road network.

**Passenger Car** - motor vehicle of road transport intended for passenger transport, in which the number of seats (including the driver) does not exceed the number 9.

**Bus** - motor vehicle of road transport intended for passenger transport with the number of seats (including driver's seat) with more than 9 seats.

Lorry/Truck: Rigid road motor vehicle designed, exclusively or primarily, to carry goods.

Motorcycle- A motor vehicle, with two, three or four wheels not exceeding 400 kg of unloaded weight.

**Trailer:** Goods road vehicle designed to be hauled by a road motor vehicle.

**Mixed transport vehicles (ATP)** - includes vehicles that have a total full load weight not exceeding 3.5 tons, or 4.5 tones when there is battery traction; are intended for the transport of people and goods with a maximum capacity of nine seats, including the driver's seat.

**Special transport vehicles (ATV)** - means of transport intended for the transport of certain goods or people under special conditions and is characterized by the equipment jointly, with special mechanisms that serve this purpose.

**Special purpose vehicles (APV)** - vehicles permanently equipped with special mechanisms and generally intended for the transport of these mechanisms; on these vehicles is allowed the transport of personnel and materials related to the operational cycle of these mechanisms, as well as the transport of people and goods related to the destination of use of these mechanisms.

**Exports**: Goods destined to a fourth country, placed under customs export or outward processing arrangements or reexported following inward processing.

**Imports**: Goods arrived from a fourth country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.
